**Newsletter July 2020** 

#### News:

Our club may not have an organized "youth group", but we do have active youth members. I've recently heard a few very impressive stories regarding some of our youth's accomplishments and I would like to showcase them in our newsletter. This month, I'll feature, **Ella Hurst's** bear hunting experience. I'm sure you will enjoy her enthusiasm. Thank you, Ella, for sharing with our club. The following is Ella's submission:

I had been getting up at 4:00 AM to go out hunting two or three times a week, and had yet to find a bear I could shoot, with not too difficult of a recovery. Finally, we spotted a massive cinnamon and a slightly smaller back bear up in a grassy clearing, which looked easy enough to access. However, on our first try, the hill was steeper than it looked and almost everything I grabbed onto, to pull myself up, just came out of the ground. After climbing for almost an hour, we decided we were not going to reach it any time soon, and by the time we did, it would be the middle of the afternoon. A week later, on our second try, we managed to get to the clearing, using a less steep route. When we arrived, the massive cinnamon had already left, but the black bear was still there. Though it would have been a relatively easy recovery (rolling it down the hill) it was a 200m shot, which I did not want to take.

Several nights later, on June 7, after our daily 7:00pm pots and pans banging, as support for the healthcare workers, my dad, Gord Hurst, and I decided to go for a quick evening hunt. We got all the way up to the top of a local logging road and just as we were about to turn around, we came around the corner and saw a black bear standing on the side of the road. As it saw us, it ran off the road and into the forest. I got out with my gun, a 300 winchester magnum, and hoped the bear would walk back out onto the road. Sure enough, it came back and presented a perfect broadside shot. I took the shot and the bear ran about 10 yards before collapsing and falling down the ditch. I was ecstatic that I had just shot my first bear! As we walked up to double check that it was indeed dead, I was jumping and squealing, with an ear-to-ear smile. I cut my first bear tag! Before pulling it up to the road, we took several pictures. Then we tried pulling it up with just the two of us, but the bear was very heavy and the embankment was very steep. So, we tied a rope to the back of the truck and pulled it up using that. We took a few more pictures on the road, then to get the bear in the bed more easily we pulled the truck into the opposite ditch. It rolled right in! After picking up all our ropes, we headed down the road, hoping to get to Kosiansics (to see the live weight) before they closed. The entire recovery took about ten minutes, including stopping to take the pictures. Unfortunately, when we got to Kozy's, it was too late. At the

junction we called Matt and Tess Nutall to see if they wanted to help skin it. On our way back to town, we went up another logging road to gut the bear on the tailgate. Back in town, Matt and Tess met us at our place and we got the bear into our basement and hung it from the rafters. With music playing in the background, Tess and I set to work skinning the bear. We finished just past midnight, and wrapped the bear in a game bag for the night.

The next morning, my Dad and I brought the bear to Kozy's, where we discovered its hanging weight was 170lbs, the second biggest bear of the season (at the time). We got to keep the skull and the claws, which I am really happy about. Overall, I had an incredible experience getting my first bear and want to thank my dad, Gord Hurst, and Matt and Tess Nutall who helped me skin it, as well as all our other (hunting and non hunting) friends who shared in my enthusiasm and helped make it such a memorable experience. ## **Cottonwood Lake Preservation Society Update:**

Progress is occurring. The RDCK purchased a strip of forested land along the uphill side of the access road and the CLPS has an agreement with the landowner, Nelson Land Corporation, to purchase an additional larger area encompassing the steep hillside on the west side of the lake. It was agreed that logging would be halted while the society fundraises. The land purchase is vital if we are to save the very beautiful setting and reduce the all too real risk of landslides into the lake if the hillside is logged.

The total cost is \$750,000. This will not only purchase the land but will also cover fundraising costs and a conservancy endowment to the Nature Conservancy of Canada, which will become the owner of the property after the purchase is completed. The conservancy endowment will cover future costs of the Nature Conservancy's management of the property.

The agreement contains a number of milestones – deadlines by which a certain amount must have been raised. A major payment of \$180,000 must be raised by August 31. The society has already collected well over \$80,000 but is finding the covid-19 pandemic is reducing the pace of donations.


## A Mysterious Bighorn Sheep:

The herds that we have collars on are easier to identify their summer/winter ranges." 
